1. OPENING

(a) Welcome

The President opened the meeting and advised the proceedings for the meeting.

The President advised that a Vice-President would introduce Agenda items, and that when there is a submitter to the Submission or paper being discussed, they will be invited to talk to the item. The respective Committee Chairmen will then present their Committee's recommendation, then the discussion will be open to the Council for debate.

The President advised that abstentions would not be counted in the voting when seeking a majority and that he would only vote to make a decision.

2. PRESIDENT AND EXECUTIVE COMMITTEE REPORT

(a) President's Report

Council received a verbal report from the President in which he highlighted the:

- Status of sailing as an Olympic Sport and the IOC review of the Olympic Programme,
- Diversity of sailing and role of ISAF,
- Evolution of sailing over the past ten years and challenges ahead,
- Global spread of sailing and ongoing promotion and participation,
- Image of sailing and ISAF,
- ISAF financial position and sources of revenue
- Professionalism within sailing,
- Future Opportunities for the sport.

In concluding his report, the President highlighted the exciting opportunities ahead, tempered with the need to be attentive to the world and the economy, whilst remaining on pace with the development of sports trends.

(b) Executive Committee Report

The President presented the key decisions taken by the Executive Committee since the Council Meetings of 14-15 May 2005, and noted that ISAF Recognition has been given to the Yachting Journalists Association and is being discussed for the International Coaches, that a working party has been appointed to develop the concept of the World Cup of Sailing (as proposed in Submission 091-05), and the ongoing development of the In-House Certification project.

3. MINUTES OF PREVIOUS MEETINGS

(a) Council Minutes

Council noted the minutes of their previous meeting of 14-15 May. There were no matters arising not otherwise covered on the Agenda.

(b) Executive Committee Minutes

Council noted the minutes of the Executive Committee Meetings of 12, 13 and 16 May 2005 and of 10, 11, 12 September 2005.

4. ISAF STRATEGIC PLAN

The President presented the ISAF Strategic Plan (see Appendix 1) and noted that the document is the first step in a co-ordinated programme to create a common framework for action to which all levels of the sport may be directed.

The key implementation dates to move the plan forwards were presented. It was noted that presentations had been made to all ISAF Committees on the implementation of the plan and Committee involvement in the Project Groups.

The President presented the ISAF vision for the sport:

"Attractive, united and globally thriving participation sport offering current and future generations a wide diversity of accessible challenges and opportunities throughout their lives."

The President emphasised the challenge ahead but also the need to evolve a plan involving all stakeholders in the sport.

Council approved the recommendation of the Executive Committee to increase the ISAF Subscriptions by 5% effective 1 January 2006. (31 in favour, 3 against, 1 abstain)

(d) <u>Budget 2006</u>

The Secretary General presented the budget as proposed by the Executive Committee for the period 1 January 2006 to 31 December 2006 (see Appendix 2).

As is normal practice, it was noted that dependent on the decisions taken during the Council meeting, the budget may need to be revised and re-presented at the 2006 ISAF Mid-Year Meeting.

Decision

Council approved the budget for the period 1 January to 31 December 2006. (35 in favour, 1 against, 0 abstain)

(e) Forecast

Council noted the presentation by the Secretary General on the four-year forecast of Olympic income from the 2004 Olympic Games, for the period through to 2008.

6. COMMITTEE ACTIVITY REPORTS

(a) Reports from Committee Chairmen

Council received brief reports from the Committee Chairmen on the key areas of activity by their Committee during the period 1 January 2005 through 31 October 2005, which it was noted would also be reported in the ISAF Annual Report 2005:

(i) Audit Committee - Joe Butterfield

Reported on the work of the Audit Committee to review the audit process and risk management profile that ISAF has recently established.

(ii) Constitution Committee - David Lees

Reported that during the year the Constitution Committee has formed a number of working parties who have developed proposals before the Council. A number of informal interpretations of the Constitution and Regulations have been issued. Committee Chairs have been supported in preparing Submissions and work has been undertaken with submitters to prepare the necessary regulation wording if approved by Council.

(iii) Equipment Committee - Dick Batt

Reported on the first year of work within the new Technical Committee Structure and success of the revised process to approve class rule changes.

It was noted that the Equipment Control Sub-Committee has focused on progressing projects on certification and certification control, equipment inspection and technology in electronic hull measurement.

Council noted that work is ongoing to review ways of controlling costs for Olympic equipment.

(iv) Events Committee - Bjorn Unger

Council noted the work by the Events Committee on the review of the Olympic Competition format and the process of the selection of equipment for future Olympic Sailing Competitions. Work had been undertaken on the allocation of unused quotas within the Qualification System for the 2008 Olympic Sailing Competitions. There is ongoing work regarding the use of onboard cameras and proposals will be presented to the Mid-Year Meeting.

(v) ISAF Classes Committee - Jeff Martin

Council noted the work of the Classes Committee and the process of communication by which each Class has input to the relevant Submissions via the Classes Committee.

It was noted that a specific issue of concern to classes is insurance, for classes, events and sailors.

(vi) Match Racing Committee - Henry Menin

Noted that the Match Racing Committee has reviewed the standard Notice of Race and Sailing Instructions for Match Racing events which were published earlier in the year. The highest priority has been the development of the Nations Cup regional finals and grand final, which get underway in 2006. The Committee has worked with the International Umpires Sub-Committee and held Match Racing Clinics to areas that request instruction and training in match racing tactics and strategy. The Match Racing Committee has also actively been working on the reintroduction of match racing to the Olympic Programme.

(vii) Offshore Committee - Philip Tolhurst

Council noted the areas of progress including the development of a specific calendar for all offshore events, updating of the ISAF Offshore Special Regulations, unification of rating systems, the development of a united approach to level class handicap systems, increasing participation in offshore sailing and the use of tracking systems.

(viii) Race Officials Committee - John Doerr

Noted that in the key area of education, by the end of the year ISAF will have held 25 clinics or seminars in 23 different countries. An International Umpire Conference was held to develop a consistent approach to the role of Chief Umpire, and a one day workshop was held to develop the performance assessment of umpires, which also increased the number of IU assessors.

A focus on the consistent application of RRS 42 has been supported by the approval of a budget for an ISAF Official to attend events during 2006 to provide clinics to judges, coaches and sailors.

The Race Officials Committee continues to focus on increasing the total number of Race Officials.

(ix) Racing Rules Committee - David Tillett

Main activities of the Committee were noted as the finalization of Racing Rules interpretations, production and publication of the ISAF Case Book, development of a standard Sailing Instruction for RRS42. The Rapid Response Working Party has responded to a number of questions throughout the year.

(x) Regional Games – Ajay Balram

Council noted that there are approximately twenty Regional Games which include sailing on their programme. During the year the Committee has appointed the Committee Members as liaison officers to the various Regional Games. Working up to four or six years ahead, the Committee has continued to support the inclusion of sailing on the sports programme of all Regional Games.

(xi) Windsurfing Committee – Phil Jones (Vice-Chairman)

The most significant work of the Windsurfing Committee was noted as the development of the RS:X and addressing the initial development issues with the equipment. The success of the RS:X event in Cadiz, Spain with over 100 entries was noted.

(xii) Women's Sailing Committee - Adrienne Greenwood

The introduction of a mentoring/budding programme between existing and new female Committee Members was reported and noted as having been very successful. The online Women's forum has addressed 19 different topics throughout the year. Ongoing Committee discussions have focused on a women's competition calendar, seminars for women, the role of the Women's Sailing Committee and Women's Forum.

(xiii) Youth and Development Committee - Ross Robson

Council noted that much of the Committee work had been information sharing on what they each felt were the important issues challenging participation in the sport and ways in which participation can be increased. Focus has also been on the different cultural issues facing participation in the sport and the need to encourage further support developing sailing nations.

(b) Report on Radio Controlled Sailing (RSC)

A representative was not present to make a verbal report from the Radio Controlled Sailing on activities in 2005.

(c) Report on World Speed Sailing Records (WSSRC)

John Brooks, WSSRC Council Member, presented a report from the World Sailing Speed Record Council on activities in 2005, which highlighted the increased attempts to break the Outright World Sailing Speed Record set in 1993, which had been broken twice in November 2004 and subsequently in April 2005 by Finian Maynard (IVB), who recorded a final speed of 48.70 knots.

The increased activity in passage records was noted with a high success ratio of records claimed to attempts undertaken, with the most notable achievement being the single-handed round the world record set by Ellen MacArthur (GBR) in February 2005 of 71 days, 14 hours, 18 minutes and 33 seconds.

(d) Report from the International Foundation for Disabled Sailing (IFDS)

Serge Jorgensen, IFDS President, presented a verbal report from the International Foundation for Disabled Sailing (IFDS) on activities in 2005, noting the awarding of a

third Paralympic medal to sailing from 2008 onwards for a two-person event, and that the equipment had been confirmed at the recent IFDS AGM as the UD18.

It was noted that IFDS has approved a new Constitution and expanded its Committee Structure. IFDS has changed the focus on disabled sailing to an accessible sport where sailors can compete together.

7. **ISAF FULL MEMBERS**

Council received the recommendation from the Executive Committee on applications ISAF Member Status

8. ISAF CONTINENTAL MEMBERS

Council noted the application from the Pan-American Sailing Federation to become an ISAF Continental Member for two continents, North America, and South America and the Caribbean, in line with the ISAF definition of continents.

It was noted that the Constitution Committee had advised that as the region over which the PASF has jurisdiction covers two continents it does not represent "a continent" in line with the ISAF Regulations and therefore the application could not be considered.

However, it was noted there was nothing in the ISAF Regulations prohibiting the Pan-American Sailing Federation from applying for ISAF Affiliate Member status.

Decision

- 1. Council rejected the application by the Pan-American Sailing Federation to become an ISAF Continental Member. (3 in favour, 30 against, 4 abstain)
- 2. Council approved the Pan-American Sailing Federation as an ISAF Affiliate Member. (32 in favour, 2 against, 1 abstain)

9. NEIL PRYDE RS:X

The President introduced the item by advising that when Rich Jeffries was appointed to the RS:X Class he stepped down as Chairman of the Windsurfing Committee.

Council received a verbal report from Rich Jefferies on the RS:X, who highlighted that Neil Pryde has committed to supply boards for the Volvo Youth Sailing ISAF World Championship and the World Sailing Games. It was also noted that the dedicated RS:X website provides up to date information as well as a forum for coaches and athletes.

10. CLASS CONTRACTS

The Chairman of the Constitution Committee advised that he was still working on the draft of a standard Class Contract with the Chairman of the ISAF Classes Committee, and that a Submission would be presented to the 2006 ISAF Mid-Year Meeting.

11. SUBMISSIONS

<u>Answer 4</u> - As the nominee of a specified Committee does not have to be an ICA appointment to the ISAF Classes Committee there is by definition no requirement for that person to remain appointed by an ICA to the ISAF Classes Committee.

- (e) Recommendations from the Events Committee
 - (i) Deferred Submission 049-04 Competition Format

Recommendation

The Events Committee recommends to council rejecting Submission 049-04 from the Royal Netherlands Yachting Union about the competition format (inclusion of match racing) in the Olympic Sailing Regatta. It was felt this Submission should be made at the appropriate time and can not be accepted at this moment.

Decision

Council rejected Submission 049-04. (5 in favour, 31 against, 0 abstain)

(ii) Deferred Submission 056-04 – Equipment to be selected for Future Olympic Regattas

The Royal Netherlands Yachting Union withdrew Submission 056-04.

(iv) Deferred Submission 071a-04 - Grade 1 Events

Recommendation

The Events Committee recommends to Council defer Submission 071A-04 from the Royal Netherlands Yachting Union about the format for ISAF graded events and refer this to the Working Party dealing with the World Cup for the Olympic Classes concept.

Decision

Council approved that Submission 071a-04 be deferred to the Working Party dealing with the World Cup for the Olympic Classes concept. (35 in favour, 0 against, 0 abstain)

(v) Agenda Item 13 – ISAF Rankings Sub-Committee

Recommendation

Grading of Events

At the request of the Regional Games Committee the Sub-Committee discussed that Regional Games could be graded in the future in order to recognise the achievement of the athletes at these games as well as the recognition of the events and organizers. The present policy has been not to grade the Regional Games due to the fact that Regional Games are restricted to certain countries. All graded regattas should in principle be open to all competitors from every country.

The Sub-Committee recommends that ISAF in the future give a grade 3 to classes in the regional games, which fulfil the present criteria for grading of

events with regard to participation. In special cases with strong participation, the Sub Committee should, on application, consider the possibility for a grade 2 (example: the Asian Games). With regard to other all other events the present decisions of principle will be maintained: "closed" events or events for a defined category like youth and masters will not be graded with the exception of ISAF Events and events where at least the top three on the appropriate rankings immediately prior to the event shall be entitled to enter.

If this recommendation is accepted, the Sub-Committee proposes that this grading policy is to apply this year and that a Submission from the Chairman of the Events is prepared for November 2006 to amend the regulation accordingly.

Decision

Council approved the Recommendation. (37 in favour, 0 against, 0 abstain)

(vi) Agenda Item 14 - ISAF Youth World Championship Sub-Committee

Recommendation

2009 The ISAF Youth Sailing World Championship
The Sub-Committee recommends for the 2009 ISAF Youth Sailing
Championship that the bid from the Brazilian Sailing Federation to host the

Championship in Buzios, Brazil is accepted, subject to a successful site visit and satisfactory contractual arrangements.

Re-allocation of unused Qualification Positions

The Events Committee recommends to Council accepting the following proposal:

Outline Proposal

Given the historic information and other Accepted Criteria above, our recommendations regarding the re-allocation of unused quotas are as follows:

- (a) Unused Quota Places (UQPs) will only be available to Nations in continents that were under-represented at the previous Olympic Regatta when compared with the percentage of MNAs in that IOC Continental grouping. (Drafting Note: Currently Africa, Oceania, Asia and America)
- (b) Unused quotas will be offered to Nations in four events:
 - Boards Men
 - Boards Women
 - Single-handed Men
 - Single-handed Women

(Drafting Note: Unused quota places may result from any of the Olympic Events. Single-handed events provide greater opportunity for a greater spread of participation from continents.)

- (c) Nations seeking an UQPs shall make an application to ISAF by no later than 1 June 2008, specifying the Event or Events in which the UQP is being sought. The application will include confirmation from the relevant NOC that the UQP(s) will be taken up if offered. Applications may be made for more than one Event, noting that places will only be offered in the four Events detailed in 2 above.
- (d) ISAF will produce a "Unused Quota Places Re-allocation List" (UQPRL) for the Events listed in 2. above, following the second of the two Olympic Qualification Events (OQEs). This list will be based on the finishing order of the second of the two OQEs. The UQRL will exclude Nations that have qualified through the OQEs.
- (e) UQPs will first be offered to Nations that are not already represented in any other Events at the Olympic Regatta, following the OQEs.
 - (i) If places are still available after all applications from these Nations have been met, UQPs will be allocated to Nations represented in one other event,
 - (ii) If places are still available after all applications from these Nations have been met, UQPs will be allocated to Nations represented in two other events.
 - (iii) and so on, until all UQPs have been allocated.
- (f) UQPs will be allocated to the highest placed Nation in the UQRL. The first place will be allocated in the Boards Men Event, followed by the Boards Women Event and so on, until all available UQPs have been allocated. Once a UQP has been allocated to a Nation in an Event, that Nation will be deemed to be represented in the Event for the purposes of 5. above.
- (g) Athletes taking up unused quota places must have appeared on an Official ISAF World Ranking List between I January 2007 and 1 July 2008.

Decision

Council approved the Recommendation. (35 in favour, 0 against, 1 abstain)

- 17.1 Only ISAF Classes shall be selected for ISAF events.

Reason:

The current regulations are obstructive to ISAF introducing to its own events those Classes it has recommended following equipment evaluation trials.

Council noted that the changes to the regulations were required to enable a non-ISAF Class to be used at ISAF Events in exceptional circumstances.

- (v) The Match Race Committee shall retain its responsibilities under its Terms of Reference for events in the Tour.
- (vi) Invitations to events on the World Tour will be based on the ISAF ranking list and Grading Criteria.
- (vii) 4 entries to each event will come from approved, graded qualifying events published well in advance.
- (viii) 1 or 2 wild cards may be invited to each World Tour event.
- (ix) There will be an open way to get on the Tour, as outlined above.
- (x) A women's tour should be established, but not necessarily a Women's World Championship Tour at this time.
- (xi) The Open World Champion shall not be decided before the last Tour event for that year.
- (xii) ISAF will agree the criteria for becoming an event on the Tour.
- (xiii) The calendar of Tour events to be considered with other non-Tour events to avoid conflicts wherever possible.
- (xiv) ISAF will retain its current grading system with modifications to the ranking criteria that make it more credible.
- (xv) The spread of events to have a global perspective to the extent possible.
- (xvi) ISAF to retain the right to appoint a Technical Delegate to Tour events.
- (xvii) The Tour shall not affect the grading of other events that are not part of the Tour.

In discussion Council approved the proposal for ISAF to license the rights to organize the Open Match Racing World Tour to an event management company for an initial period of two years, but with the Executive Committee retaining the right to agree a longer sponsorship period.

It was noted that the recommendations of the Match Racing Committee are guidance and not mandatory requirements.

Council Decision

I. Council approved the principle of holding an Open Match Racing World Championship determined through a series of events in

The President advised that the IOC would review the Olympic Programme systematically each quadrennial. Each sport would be evaluated based on a set criteria which assesses the strengths and weaknesses of each sport and the value that sport brings to the Olympic Programme.

14. ISAF EVENTS

Helmut Jakobowbitz presented a verbal update on arrangements for the World Sailing Games and highlighted the forthcoming entry deadline of 1 February 2006.

He expressed concern that having introduce a multihull women event at the request of female sailors, that to date there were insufficient entries.



INTRODUCTION

This strategic plan sets out ISAF's vision for worldwide sailing and its approach to meet and develop the envisioned future.

The plan identifies nine high level objectives with particular focus areas that determine the direction that ISAF believes that the sport should take. It is to these objectives to which ISAF strategic planning will be directed and cascaded to all levels of the sport.

Successful growth and development of sailing will derive from activities undertaken at grass roots level led by Member National Authorities, Classes and Continental Associations who will play an integral and crucial role in achievement of the vision.

The plan is built upon good work that has already been taken and also identifies new areas of opportunity. As a framework for the whole sport its success will be dependent upon the development of individual strategic plans and initiatives at all levels of the sport. Individually these will recognize the priorities and needs of individual countries but together will support ISAF objectives.

Following ISAF Council approval of the Strategic Plan, ISAF will prepare a co-ordinated approach to implement the Plan through detailed planning and authorisation of specific Proposals. Proposals will be identified by Project Groups formed from ISAF Committee and Council members. The Proposals will vary in scale from strategic plans that may require further development to clearly defined activities that may be implemented immediately.

The ISAF Strategic Plan will be a key document for development of the sport and its launch will provide a common theme for constituent groups to follow whilst implementing individual development activities that remain appropriate to their own circumstance. It will be reviewed annually.

Implementation of the plan is will be a challenging task but unqualified commitment to it is an essential step to secure the **future of sailing** and **create a lasting legacy** that may pass to future generations of sailors.

ISAF is the governing body of the sport of sailing in all its forms throughout the world. ISAF envisions sailing as an attractive, united and globally thriving participation sport offering current and future generations a wide diversity of accessible challenges and opportunities throughout their lives.

APPROACH

In accordance with its objects ISAF, will uphold its vision through the promotion of sailing and continuing innovation in the development of long term appeal, accessibility, participation and value across the world, regardless or race, religion or gender (or political affiliation). The commitment of ISAF to the participation of women within the sport will remain a cornerstone throughout all of its policies.

OBJECTIVES

ISAF has identified nine objectives as key steps in meeting its vision of the future of sailing. For each objective, focus areas have been identified that are considered central to success and to which it is proposed that available resource be directed and prioritised.

Objectives and focus areas have been identified through consolidation of key issues proposed by ISAF committees and possible actions that may serve to address them.

The actions provide the detailed background to preparation of the Strategic Plan and have been recorded within a supplementary Action Record.

Subsequent to approval by Council of the high level **strategic** objectives covered by this document, the Action Record will be available to Project Groups to provide further detail and support for their development of the objectives. This approach enables continuity in development of implementation proposals without the loss of earlier work or strategic decision makers becoming unnecessarily involved in detailed implementation.


